## INTERNATIONAL FUNDS TRANSFER

These instructions are to provide to your bank in the event of multicurrency account funding only.

### Euro Foreign Currency Account Funding Instructions

Receiving accurate and timely payment instructions are critical for ensuring the smooth operation of your Multicurrency Account. If you have any questions regarding these payments instructions, please call Harris' Global Payment Services at **(866) 278-2444**.

Send by SWIFT, if possible.

Send two SWIFT messages:

- (1) Message type 103 (**MT103**)\* to **HARRIS N.A.** (SWIFT address: **HATRUS44GTM**) for payment notification. Include the following fields of information:
  - 32A:** Value Date, Currency Code, Amount
  - 50:** By Order Of
  - 54:** Receiver Correspondent
  - 59:** **/089-454-974-7** (30.7 Secured Account Number)  
TransAct Futures
  - 70:** Details of Payment (this can include customer information, trade number, or any other data - only the first 24 characters of this field will appear on your Daily Statement).
  - \*\*72:** */OCMT/(ERI or euro related information if needed)*

**\*Caution: To avoid lifting charges, do not send an MT103 message to Harris Bank's correspondent, Deutsche Bank.**

- (2) Message type 202 (**MT202**) to **DEUTSCHE BANK, FRANKFURT** (SWIFT address: **DEUTDEFF**) for cover instructions. Include the following fields of information:
  - 21:** Data from field **20:** of MT103 (referencing MT103 message)
  - 32A:** Value Date, Currency Code, Amount
  - 58A:** **/100959119900**  
**HATRUS44GTM**
